1) Legislation Title:

Approve, deny, and terminate Single Family New Construction Limited Tax Abatements from January 1, 2011 to December 31, 2011. (Resolution)

2) Purpose of the Proposed Legislation:

The Resolution approves, denies, and terminates tax exemptions for builders of single family units or property owners under the Single-Family New Construction Limited Tax Exemption program (SF LTE) The goal of the SF LTE program is to increase minority home ownership and encourage new construction of single family homes in areas designated as "Homebuyer Opportunity Areas".

4) Revenue: Will this legislation generate or reduce current or future revenue coming to the City? If so, by how much? If so, please identify the source.

The 147 approved Single Family New Construction Limited Tax Abatements will increase revenue for the City of Portland in the form of a one-time application fee. A total of \$750 is collected for each completed and approved application, \$300 towards PHB administrative costs and \$450 is paid to Multnomah County for administrative costs. Additionally, for each LTE being terminated (7 total), \$1,764 will be added annually to the tax rolls.

This legislation will decrease revenue for the City of Portland in the form of forgone revenue. The 147 approved Single Family New Construction Limited Tax Abatements represent an estimated average of \$1,764 in foregone property taxes per year for each unit, for total annual

forgone revenue of \$2,593,080 over ten years. These dollar amounts include taxes foregone by the City of Portland, Multnomah County and other entities which receive property taxes within Multnomah County.


