

To Whom it may concern, within the last two years or so I have sent you two letters about a racketeering group that lived themselves into a Portland and Milwaukie home of mine. Soon I found myself surrounded by drug dealing, prostitution and fraudulent activities. The only way of escape was to leave my deposits and personal property. One time I barely got away with my life also in a police report. I went to Portland City Council told them the same and asked if I was in something governmental. One of a number of reasons the lack of help from the local authorities. The Mayor's office said that I was not in any program according to his knowledge, so I did not include this information in my past letters to you. I am writing you now to say I believe strongly that I am in one, either way corruption has crept into the local governing agencies by this group. I've lived most of the time in my car since those two invasions and still felt I was followed especially after my many letters, police reports and City Council inquiries. Driving all over I hoped to lure them into the open. It was working but because of them interfering with my work I had to exit my car. I then lead them to a secluded spot under the 205 bridge a kind of stand off to see how well I had pulled them out. This is when it really became apparent I was part of some program or just straight corruption, since they followed but mostly the yellowish-orange city worker trucks, acting like they were working in under the bridge climbing up a manhole inside above me. I believe it was becoming increasingly unsafe there and knowing they were successfully following lead me to the downtown area around Burnside and Waterfront in hopes of putting them out again but in crowds of people not just cars in parking lots as before. Finding witnesses for the police in their reports always seemed to be a problem for them. In the crowds all summer long it became very clear there main focus beside the drug dealing and other crimes mentioned, mostly child sexual exploitation. I have some leads for the next inquiry of my investigation. Paying close attention to people coming and going out

of my life I determined City Bible Church 9200 NE Fremont, ST
Portland, OR 97220 knows who these people are and have worked with
them. On the street I have also heard them mention Gypsy Joker
and Boke's as aliases. Most likely part of some media film someone
tried to include this in. Their connection of this church local
government and their main focus with children leads me next to
two organizations DHS, planned parenthood and a christian organization
called with human trafficking. Since involving me it must be from
my exwife. In a police report in Beaverton almost seven years ago
she took off with my children and I have been looking for them ever
since. The circumstances of my investigation has got myself into county
jail for not being able to pay my child support but I am not counting
out it being some leverage ploy from this crupcion. The end of my six
month sentence ends March 29TH. You can respond to my letter, here
before then with any help or concern. Other than that I will find
the truth.

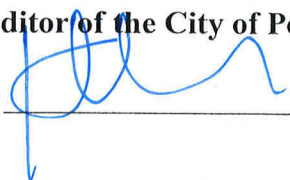
