Subject: Presentation to Council – Overview of Portland Harbor Superfund Process

The Portland Harbor was listed as a Superfund site by the federal government in December 2000 due to contaminated sediment in the river. The City of Portland is involved in Portland Harbor in many ways and has been an active participant in the Lower Willamette Group. The Lower Willamette Group is a group of potentially responsible parties who have voluntarily stepped forward for the initial phase of the Superfund work. This group conducted and paid for the Remedial Investigation and will be submitting a Draft Feasibility Study to the U.S. Environmental Protection Agency (EPA) on March 30, 2012. The Draft Feasibility Study will provide information to help EPA develop a cleanup plan.

The Office of Healthy Working Rivers and Bureau of Environmental Services are presenting this briefing to Council to provide background on the Portland Harbor Superfund Site in anticipation of EPA's receipt of the Draft Feasibility Study.
