Transmit summary of sponsorships and donations received by the Bureau of Transportation in calendar year 2010, as required by Ordinances 179806 and 182573.

City Code stipulates that any donation, gift, grant, lease, or loan exceeding \$250 shall first be approved by City Council. Ordinance 179806 authorizes the PBOT Director to execute agreements accepting sponsorships, donations, contributions and cost sharing agreements for transportation programs, in a form acceptable to the City Attorney, and in amounts not to exceed \$150,000. Ordinance 182573 authorizes the PBOT Director to accept and acknowledge individual sponsorships, donations, and contributions for Sunday Parkways projects in amounts not to exceed \$10,000 per individual per year.
