TO THE COUNCIL

The purpose of following report is to notify Council that the report regarding the November 2010 elections incorrectly stated the number of votes cast for governor in the Municipal Non-Partisan General Election held in the City of Portland on November 2, 2010.

The previous report incorrectly stated that 233,820 votes, including 1,527 in Washington County, were cast for governor within the City of Portland. The correct number of votes cast in Washington County were 513, totaling 232,806 within the City of Portland. The correct number of total votes cast is as follows:

Per ORS Section 249.870, the requisite number of signers on a recall petition is based on the total votes cast for all candidates for Governor at the most recent election. The correct number of requisite number of signers is as follows:
