7. **BACKGROUND/ANALYSIS:** Ordinance Number 184326 adopted on December 15, 2010, authorized a contract and payment for the construction of the Fire Station 18 Seismic Upgrade and Facility Remodel project.
8. **FINANCIAL IMPACT:** The estimated project cost was \$ 1,509,700.00. Per the bid submission, the total amount is \$ 1,365,000.00. Funds for this project are available in the FY 2010-2011 Fire and Rescue Facilities GO Bond Construction Fund budget.
9. **RECOMMENDATION/ACTION REQUESTED:** Accept bid of 2KG Contractors, Inc. for the Fire Station 18 Seismic Upgrade and Facility Remodel for \$1,365,000.00.
