#### 7. BACKGROUND/ANALYSIS

There is currently one vacancy on the Business License Appeals Board due to the expiration on December 31, 2011 of the term of Harry R. Jordan. Mr. Jordan has agreed to be reappointed to the Board.

The Board position previously held by Harry R. Jordan is to be appointed by the Mayor. If reappointed, his term would expire on December 31, 2013 (2 years).

Portland City Code section 7.02.295 D requires that appointments to the Business License Appeals Board be made to provide an appropriate level of expertise in accounting methods and tax regulations. The potential appointee meets the qualifications required by the code and should serve both the public and the City of Portland well in any matters coming before the Board.
