## 7. BACKGROUND/ANALYSIS

This is a claim for bodily injury resulting from an automobile collision that occurred on March 31, 2010, on Interstate 84 near Wood Village. An employee of the City of Portland Police Bureau, driving a City-owned vehicle, rear-ended Christine Stolebarger's vehicle on the off ramp of the freeway. The collision was caused by the officer's failure to leave adequate stopping distance as he was exiting. Ms. Stolebarger was injured in the collision.

Liability on the part of the City's driver is clear. We paid \$5,000 directly to Ms. Stolebarger in settlement of her claim for noneconomic damages. The remaining balance, to be paid to GEICO Casualty Company pursuant to this Ordinance, is \$3,172.10. This is reimbursement for medical care paid for by GEICO under its auto insurance policy.

## 8. FINANCIAL IMPACT

Approval of the settlement would result in payments from the liability fund totaling \$8,172.10, consisting of the \$5,000 previously paid to Christine Stolebarger, and the balance of \$3,172.10 being paid to GEICO Casualty Company under this Ordinance.

## 9. RECOMMENDATION/ACTION REQUESTED

Approve settlement of Christine Stolebarger bodily injury claim in the total sum of \$8,172.10.
