I meet with Eloise Damrosch, Cynthia Knapp, and Helen Daltoso of RACC last year because I had tried to go to several community art events which were funded by city funds were not wheelchair accessible or offering interpretation or other accommodations. After that meeting, Helen Daltoso started a process of assessing which grantees were in violation of 504 and ADA, which venues were ADA accessible and dramatically changed RACC's grants process to assure that grantees were both aware of their obligations to be accessible to the full community and actively taking steps to accommodate individuals with disabilities. Now grantees have to actively affirm their understanding and compliance with ADA access or they are not granted funds. Helen included a large section in the grantee training this year around access and how grantees can achieve access requirements. She also has participated in an Oregon Arts Commission process to look into increasing access to the arts at a State level.

Whereas many arts administrators do not take this issue seriously, Helen has taken this on issue head on, with enthusiasm and clarity and her approach and efforts are significantly changing the arts landscape to make the arts more accessible to all citizens. I can count at least 6 events and projects in the last several months that are now accessible (and will remain so) that would not have been accessible without her leadership. This area, arts access, is often overlooked as not being a "basic need" (which I wholeheartedly disagree with). Her advocacy has brought the issue to attention and resolved issues that have been longstanding and problematic for people with disabilities in Portland. Helen is making a huge difference and deserves recognition.
