Subject: Nominees for Appointment to the North Reach Advisory Committee

The Council directed the appointment of the North Reach Advisory Committee when it adopted the River Plan/North Reach (Resolution 36778) on April 1, 2010. I am pleased to present the names of twenty community members who have agreed to serve on the North Reach Advisory Committee.

The role of the North Reach Advisory Committee (the Committee) is to oversee implementation of the River Plan/North Reach and to assess and report annually to the Planning and Sustainability Commission and the Council on the Plan's effectiveness. Information on the implementation of the River Plan/North Reach will be considered as the City develops plans for the Central and South Reach of the Willamette River.

Recruitment for Committee members began in May 2010 and was concluded in June 2010. A list of applicants was provided to Commissioner Fritz, the Commissioner in Charge of the Office of Healthy Working Rivers and Mayor Adams, the Commissioner in Charge of the Bureau of Planning and Sustainability.

The applicants Committee reflect a diverse group of interests in the implementation of the River Plan/North Reach. Committee members include representatives from several river neighborhoods, representatives of industry, labor, environmental groups, recreational users, the Port of Portland, property owners and individuals representing broader public and regional interests.
