## ORDINANCE No. 185282 As Amended

\*Authorize a \$20,770 grant agreement with Kenton Action Plan dba North Portland Community Works to administer Neighborhood Small Grants for thirteen neighborhood and community building projects (Ordinance)

The City of Portland ordains:

## SECTION 1. The Council finds:

- 1. The Neighborhood Small Grants Program provides neighborhood and community organizations an opportunity to expand their community-building capacity, attract new and diverse members and sustain those already involved.
- 2. This program has been adopted as part of the FY 2011-12 Office of Neighborhood Involvement (ONI) budget and is funded with a total of \$223,039 through City General Fund dollars. \$24,435 of these funds is allocated to North Portland Neighborhood Services for projects in North Portland.
- 3. North Portland Neighborhood Services, which is a city-administered District Coalition, is distributing their allocated funds of \$20,770 to North Portland Community Works (NPCW) to administer funds for thirteen different projects.

## NOW, THEREFORE, the Council directs:

- a) The Director of the ONI and the City Auditor are authorized to execute a grant agreement on behalf of the City in a form substantially in accordance with Exhibit A in the amount of \$20,770.
- b) Amendments to the grant agreement may be agreed to and executed by the Director of ONI or his/her designee provided those amendments do not increase the fiscal risk to the City.
- c) The Director of the ONI and the City Auditor are hereby authorized to pay for said grant agreement from the Office of Neighborhood Involvement general funds.

SECTION 2. The Council declares that an emergency exists because there a number of community groups that are waiting for funding and inflation will diminish; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
