REPORT TO COUNCIL

July 21, 2010

Accept the West Hayden Island Community Working Group – Report to Portland City Council, dated July 29, 2010

The Community Working Group (CWG) was formed by the Mayor. They were charged with the task to advise City Council on how marine industrial, habitat, and recreational uses might be reconciled on West Hayden Island (WHI) and, if a mix of uses is possible, to recommend a preferred concept plan. While the CWG was not able to reach a consensus (requiring 75% approval under the CWG's procedures) on a recommendation, their report contains valuable background information such as points of commonality, and areas of disagreement. This background information will help the City Council determine the city's policy direction for West Hayden Island.

We recommend that Council accept the report.
