*Amend contract with DGM Systems for Equipment Maintenance Services for the SmartPark Revenue Equipment (Ordinance; amend Contract No. 34769)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Contract with DGM Systems was entered into on March 10, 2003 for a period of five years as a result of Invitation to Bid number 101977. In 2008, the City amended the contract to allow for additional compensation and the contract period was extended through April 20, 2013.
- 2. Due to PCI compliance requirements as well as on-going maintenance and servicing of the Amano McGann equipment, additional funding is required in order to assure uninterrupted servicing of the equipment through the contract expiration date of April 20, 2013. An additional amount of \$286,250.00 is required and will bring the contractual total to \$821,250.00.
- 3. DGM Systems is the only authorized distribution partner in the State of Oregon for the Amano McGann revenue producing equipment used in the SmartPark garages. They are the only business certified in Oregon to provide repair and servicing of the SmartPark revenue equipment.
- 4. The Bureau's level of confidence in the cost estimates for the remaining portion of this contract is high as PBOT has analyzed past usage of the required servicing and maintenance and is confident, barring unforeseen circumstances, that the requested additional authority will be what is needed to carry PBOT through to the contracts termination date.

NOW, THEREFORE, the Council directs:

- a. That the Chief Procurement Officer is hereby authorized to execute Amendment 7 to Contract C34769, substantially in accordance with the amendment attached to the original of this Ordinance and, by reference, made a part hereof.
- b. The Mayor and the Auditor hereby are authorized to draw and deliver warrants payable to the contractor.

Section 2. The Council declares that an emergency exists because current contract authority is not sufficient to allow PBOT to pay for ongoing services; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
