The legislation itself does not have any costs associated with it; the City has been responsible for maintaining this trail since 2007 per agreement No. 770 which transferred the right-of-way and maintenance responsibilities from the State of Oregon to the City of Portland. The City's Maintenance Operations Group is responsible for maintaining the assets associated with the trail

including pavement, striping, sweeping and signage and they do so on an as-needed basis. Since 2007 there has been very limited demand for maintenance. Looking in to the future there are a total of 2 signs on path which may need to be replaced if damaged. The path itself may require occasional sweeping but the pavement is in good condition and with only bicycle and pedestrian use it will likely stay in good condition for the foreseeable future. Our level of confidence is this estimate is optimal.
