ORDINANCE No. 185294

*Allow the City to pay up to \$20,000 per year for City portion of the operating expenses related to the Regional Radio System Partnership (Ordinance; amend Ordinance No. 182093)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On August 6, 2008 Council approved Ordinance No. 182093 which authorized the City of Portland (City) to execute Intergovernmental Agreement (IGA) No. C53173 to participate in the Regional Radio System Partnership (Partnership) with Washington County Consolidated Communications Agency, Clackamas 800 Radio Group and the Clark Regional Emergency Services Agency.
- 2. The Partnership was created as an intergovernmental entity pursuant to ORS 190.003 through 190.265, to provide governance for the region's Replacement Radio System and Upgrade project.
- 3. IGA No. C53173 dictates that the Partnership shall be self-sufficient in its operation and obtain operation and maintenance funding from the Partners. Operating costs shall be allocated among the Partners and budgeted in amounts required for operation and minor equipment replacement.
- 4. Ordinance No. 182093, passed in August 2008, did not allocate funds to pay the City's portion of expenses as the Partnership had not been formed yet; therefore, funding forecasts could not be accurately completed.
- 5. Funding not to exceed \$20,000 per year will be provided by the Bureau of Technology Services.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 182093 is amended to allocate an annual, not-to-exceed amount of \$20,000 for the City's portion of the Partnership operating expenses.

Section 2. The Council declares that an emergency exists because the City's ability to pay for operating expenses would be delayed and could place the City in default with the Partnership for nonpayment; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
