Dear Mayor and Commissioners;

My name is Elisa Aguilera. I live in the Montavilla neighborhood. I am one of the Co-directors for the Community Alliance of Tenants. I am here today providing testimony on behalf of CAT.

We want to thank you for council's past support for safe housing and affordable housing programs. CAT and many other groups have been able to leverage the city's support to rehab affordable housing buildings, provided information and referral to thousands looking for housing or housing assistance, have helped make homeowner attainable for more Portlanders, and have increased the stock of affordable housing units. Portland City Council's support has been essential to the housing community.

We are also encouraged by the substantial work that has taken place at the Neighborhood Inspections Program over the last two years to improve enforcement strategies within the constraints of existing code. However, meaningfully addressing the problem of substandard housing will require significant changes to the status quo and funding to support those changes- changes that will take further action by this Council.

Many tenants continue to struggle with their housing needs, especial during this recession. There are still too many low-income renters that are paying more than 50%, and 70% of their income in rent. The need for rent assistance programs and more affordable housing continues to be significant. On our hotline, and through our outreach program we are hearing from more and more families that are doubling up or even tripling up because that is the only way they can afford a home. Low-income people are feeling the pinch from the recession in very difficult ways. As there continues to be a shortage of affordable housing, the private market has in some ways filled the

We recognize that the majority of landlords in our City treat their responsibilities with diligence and properties with care. Unfortunately, our experience and the existing data suggest that a significant minority do not. The impact is devastating and borne by the most vulnerable in our City. With the cut programs and services from the Neighborhood Inspections program it has become drastically difficult for renters to access the program in a timely manner. We have taken steps back in our ability to provide support to renters living in hazards and inhabitable conditions. Even during this difficult financial time, safe housing needs to be prioritized. If the private market is filling the affordable housing gap, we need to make sure people are safe in that housing. We look forward to the City improving its systems and tools for holding landlords accountable in those instances where landlords willfully fail to meet their basic responsibilities.

This Council has shown its willingness to break new ground when necessary, and it is much appreciated. We look forward to your continued engagement on this issue and urge you to continue to fund and support safe and affordable housing programs and services provided by the Neighborhood Inspections Program and the Housing Bureau as a step towards ensuring that each of our neighbors has a safe place to call home.
