# **Dream Big Community Center**

Dream Big Community Center (DBCC) is a new nonprofit community center in Vancouver, WA. In July of 2007, DBCC became an official tax-exempt 501(c)(3). DBCC was created in response to the lack of development of adolescent-focused programs by social service organizations and nonprofits. In particular, DBCC is to serve the needs of teenagers in Vancouver, WA. The purpose of DBCC is to give all people in the community—although our main focus will be on teenagers—a place to go to find resources through our programs and collaborating partnerships to aid in their aspirations.

In 2008, we created three different opportunities to reach out to a neglected demographic, at risk youth. The programs are Dream Big 101, the Dream Big Essay Contest, and Banking on Our Future.

- **Dream Big 101** is a college-structured class (given in at least 5 sessions) to identify middle and high school kids' dreams, and give direction to their ambitions. During the class, the students conduct various assignments to find their passion and build their self-confidence.
- **Dream Big Essay Contest** is for 12-18 year olds to write a 350 to 500 word essay on their dream and how they plan to pursue it. Winners will receive a \$250 gift certificate, a day shadowing Big Suke from radio station 1080 The Fan, and tickets to the Trail Blazers last season game.
- Banking On Our Future, or BOOF, is a financial literacy program designed for youth ages 9-18. The BOOF program has received national recognition from the U.S. Treasury Department and has been endorsed by many financial institutions. We have implemented BOOF with our partner, Operation Hope.

In 2009, we've completed a number of milestones with all our programs, including earning Vancouver Business Journal's Business Growth Award, Nonprofit of the Year Finalist. DBCC's flagship and most popular program is Dream Big 101. We conducted Dream Big 101 at Hayes Freedom High School, Evergreen High School, and Mountain View High School teaching over 550 students. In addition, we assisted Banking on Our Future to teach financial literacy to over 750 youth. Our success in Clark County has quadrupled our income; and doubled our donors, partnerships, and sponsorships.

In 2010, Dream Big 101 will have over 600 students in four different schools. Our partnership with the Clark County government has blossomed to give us office space in the heart Downtown Vancouver. We're excited to launch new programs and impact more lives as we continue to grow as an organization.

Our ultimate goal for DBCC will be uniquely different from current recreational and community centers. The difference would be our wraparound approach of including educational, social, and

recreational services focusing on empowering youth in one centralized location. The DBCC will be a safe place for anyone to pursue their dreams without ridicule and/or repercussions. All community members would be invited to become members to enjoy all services, amenities, and resources Dream Big has to offer. DBCC will be the place to have a good time, learn, grow, dream, be empowered, to get engaged, give back, and to see dreams come to fruition.

We believe we'll be able to break ground in 2012; and open the facility in 2013.
