ORDINANCE No. 185317

*Accept a grant in the amount of \$1,351,800 from Oregon Department of Transportation for the design of the SE Holgate & SE Ramona: 122nd to 136th Ave Sidewalks project. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Bureau of Transportation applied for a Transportation Enhancement (TE) Grant in the amount of \$1,487,000 on September of 2010 for the SE Holgate & SE Ramona: 122nd to 136th Avenue Sidewalks project; and
- 2. The Oregon Department of Transportation has notified the City of Portland that it will award a grant for the SE Holgate & SE Ramona: 122nd to 136th Avenue Sidewalks project to the Portland Bureau of Transportation in the amount of \$1,351,800.
- 3. The total Project cost is estimated at \$1,593,000, which is subject to change. The TE funds are \$1,351,800 and are for Preliminary Engineering (PE) and Construction. The City of Portland can obtain additional Enhancement Funds up to a total of \$1,487,000 with approval from State's Transportation Enhancement Program Manager. City's matching share will be 10.27 percent of Enhancement eligible costs. These funds will not be expended until the fiscal year 2012/2013 budget and will be included in the adopted budget. The SAP# is T00305 and Grant ID is TR000194.
- 4. The Bureau's level of confidence in the cost estimates for this project is low. The cost estimate for the design and construction will be developed during the design phase.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation for the design and construction of the SE Holgate & SE Ramona: 122nd to 136th Avenue Sidewalks project in the amount of \$1,351,800, and to execute an Intergovernmental Agreement in substantially the form of the attached exhibit for this purpose.
- b. The Mayor is authorized to execute amendments, approved as to form by the City Attorney, to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase the City's financial risk. Increases to the grant amount must be approved by the City Council.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
