

## ORDINANCE No. 185318

\*Amend contract with Oregon Department of Transportation grant program for the SW Harbor Dr / SW River Pkwy Intersection Improvements. (Ordinance; amend Contract No. 30001448)

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 183763, passed by Council on May 19, 2010, authorized execution of an Intergovernmental Agreement with the Oregon Department of Transportation (ODOT) for modernization improvements to the intersection and approaches of SW Harbor Drive and SW River Parkway.
2. ODOT has provided an amendment to Contract No. 30001448; this amendment does not affect the total project grant amount; it does update key milestone dates. However, the original authorizing Ordinance did not delegate authority to the Commissioner-in-Charge to execute amendments that do not increase the City's financial risk.
3. In the future, Ordinances initially authorizing Intergovernmental Agreements will delegate authority to the Commissioner-in-Charge to execute amendments, approved as to form by the City Attorney, provided the changes do not increase the City's financial risk.

NOW, THEREFORE, the Council directs:

- a. That the Mayor and the Auditor are authorized to amend Intergovernmental Agreement No. 30001448 with the Oregon Department of Transportation for SW Harbor Drive and SW River Parkway Intersection Improvements, substantially in accordance with the amendments attached to the original of this Ordinance and by reference made a part hereof.
- b. The Commissioner-in-Charge is authorized to execute future amendments, approved as to form by the City Attorney, to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase the City's financial risk. Increases to the grant amount must be approved by the City Council.

Section 2. The Council declares that an emergency exists so that there will be no delays to recognizing the updated project schedule; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
