**2) Purpose of the Proposed Legislation:**

The City of Portland, Oregon Police Bureau wishes to apply for USDOJ OJP BJA grant funding for the Edward Byrne Memorial Justice Assistance Grant Program FY 2012 Local Solicitation on behalf of the jurisdictions certified as disparate - the City of Portland, Multnomah County and the City of Gresham.

The USDOJ will reimburse the City up to \$502,012 for approved program expenses. Multnomah County will receive \$193,707, the City of Gresham will receive \$61,766 and the City of Portland will receive \$246,539.

The City will incur TriMet payroll tax benefit expenses not eligible for federal reimbursement. The expenses will be provided by funds from FY 2013-14 and FY 2014-15 Police Bureau program budget appropriations. There is no match requirement.
