*Authorize a contract to purchase one full sized SUV for \$31,000 funded by Portland Bureau of Emergency Management (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The CityFleet Division of the Bureau of Internal Business Services recognizes the need for one additional full sized SUV to be used by Portland Bureau of Emergency Management so that the Operations Manager can transport emergency team equipment to incident locations.
- 2. It has been determined that one full sized SUV needs to be acquired for Portland Bureau of Emergency Management - vehicle #N12019, Exhibit A attached.
- 3. The estimated cost of this vehicle is \$31,000.00 for one full sized SUV funded by Portland Bureau of Emergency Management.
- 4. The City now desires to acquire this vehicle.

NOW, THEREFORE, the Council directs:

- The CityFleet Division of the Bureau of Internal Business Services, OMF, is hereby authorized to acquire this vehicle for use by the Portland Bureau of Emergency Management per the listed request identified in the attached, Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to pay for said purchases from the CityFleet replacement funds.

Section 2. The Council declares that an emergency exists because delay in proceeding with the purchases would result in additional expense and unnecessarily deprive the City of the use of this vehicle at an early date; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
