*Create a new Nonrepresented classification of Streetcar Officer and establish a compensation rate for this classification (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating a new Nonrepresented classification of Streetcar Officer, effective April 19, 2012.
