The cost for FY 2012-13 for BDS will be \$155, and for BES and PBOT the cost will be \$165 per permit per vehicle per month. The cost to BDS will be approximately \$9,800 per month for BDS's fleet of 63 City assigned vehicles. Currently, BES has four PSU parking permits and PBOT has one PSU parking permit for the 4th Avenue Garage. Staff from these bureaus frequently has a need to conduct field inspections. The approximate monthly cost for BES will be \$660 and for PBOT it will be \$165. BDS pays for the invoices upfront and there is an interagency with BES and PBOT to charge back these costs and to handle all of the billing, permit issues and any other customer service issues that may occur. Funds for this IGA with PSU are available in the Bureau of Development Services FY 2012-13 budget. Funds are also available for the internal interagency between BDS and BES and PBOT.

I. RECOMMENDATION

Authorize an Intergovernmental Agreement with the State of Oregon on behalf of Portland State University, for the use of parking permits and access cards at the 4th Avenue Garage and provide for payment.

II. BACKGROUND

The BDS inspection staff has parked in PSU's 4th Avenue Garage parking facility which is adjacent to the Development Services Building since BDS moved into the Development Services Building in 1999. BES and PBOT staffs that are located at the 1900 Building also have a need to park City assigned and personal vehicles in the garage in order to conduct field inspections in a timely manner. The parking structure is the most convenient and efficient in terms of access and proximity to the Development Services Building

The Bureau of Development Services has had and currently has a bureau-to-bureau interagency with BES and PBOT to handle and process all of the parking invoices from PSU to resolve any customer service issues between Portland State University Transportation and Parking Services and BES and PBOT.

III. FINANCIAL IMPACT

The cost for FY 2012-13 for BDS will be \$155 and for BES and PBOT the cost will be \$165 per permit per vehicle per month. The cost to BDS will be approximately \$9,800 per month for BDS's fleet of 63 City assigned vehicles. Currently, BES has four PSU parking permits and PBOT has one PSU parking permit for the 4th Avenue Garage. Staff from these bureaus frequently has a need to conduct field inspections.

The approximate monthly cost for BES will be \$660 for four parking permits and for PBOT it will be \$165 for one parking permit. BDS pays for the invoices upfront and through the interagency with BES and PBOT, BDS charges these costs back and for handling all of the billing, permit issues and any other customer service issues that may occur. Funds for this IGA with PSU are available in the Bureau of Development Services FY 2012-13 budget. Funds are also available for the internal interagency between BDS and BES and PBOT.

- VI. LINK TO CURRENT CITY POLICIES

Under the Urban Center Condominium agreement where Portland State University is the owner and manager of the 4th Avenue Garage, agrees to make a number of parking spaces available to the occupants of the 1900 Building. This allows the City of Portland, Bureau of Development Services through an intergovernmental agreement and on behalf of the Bureau of Environmental Services and the Portland Bureau of Transportation to pay a specific fee for such spaces.

VII. CITIZEN PARTICIPATION

The Bureau of Development Services, Bureau of Environmental Services and the Portland Bureau of Transportation do not foresee any future public involvement as parking in Portland State University's 4th Avenue Garage is adjacent to the Development Service Building and is the most convenient and efficient in terms of access and proximity to the Development Services Building.

The Bureau of Environmental Services and the Portland Bureau of Transportation desires and agrees that BDS take the lead as the main contact with PSU in terms of handling the billing, permits, and customer services issues.

BDS, BES, and PBOT have a need for parking spaces and access cards at the 4th Avenue Garage so each bureau's inspection staff can continue to park City-assigned vehicles in the parking structure.

Through this Ordinance, City Council votes to authorize the IGA for the use of parking permits and access cards for the 4th Avenue Garage.
