* Authorize an agreement with the Urban Sustainability Directors Network to receive \$18,400 to assess municipal food policy structures. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. The purpose of the Urban Sustainability Directors Network (USDN) is to:
 - Form new and strengthen relationships between cities;
 - Efficiently gather successful sustainability policies, programs and practices;
 - Learn from cities' collective experiences;
 - Address together key sustainability challenges;
 - Contribute practices and tools to the field of urban sustainability.
- 2. USDN has asked the Bureau of Planning and Sustainability (BPS) to research and publish a study of best practices as they relate to municipal food policy organizational structure.
- 3. Funding from USDN will allow BPS, in collaboration with ten other U.S. cities, to pay for staff time to coordinate, research, write, and publish the report.
- 4. No additional City resources are required to carry out the proposed project.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to enter into an agreement with the Urban Sustainability Directors Network to accept \$18,400 to assess municipal food policy structures.
- b. The Mayor and Auditor hereby are authorized to draw and deliver checks chargeable to the FY 2012-13 budget, Cost Object 9PNSF0000001, when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists for work to proceed in next fiscal year; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
