No, this agreement will not generate or reduce future revenue coming to the City. The purpose of this agreement is to authorize Verde to fundraise for park improvements at Thomas Cully Park. Verde or its contractors will be responsible for construction of the park improvements and PP&R will receive ownership of the park improvements.

As new park improvements are constructed at Cully Park, PP&R will request Operations and Maintenance funds for them. In summer 2012 Verde will construct a new community garden. The annual O&M cost total is \$5,986 and will be requested starting in the FY 2012-13 Fall BuMP by PP&R. PP&R will also make a one-time contribution of \$13,500 to Verde for construction of the community garden.
