a) What impacts are anticipated in the community from this proposed Council item?

It is expected that the East Portland community will greatly benefit from enhanced community involvement and projects that will address the East Portland Action Plan Civic Engagement Action Plan item: Community Building.2.3 Develop and hold leadership and civic engagement classes/programs for East Portland citizens to build capacity for participating in lobbying, advocacy, board participation, partnership, etc., with a focus on culturally specific communities in language appropriate ways.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

Members of the East Portland Action Plan (EPAP) Civic Engagement Subcommittee drafted the grant application and assessment criteria. Membership included representation from the school, African American, Chinese, Vietnamese, African, Native American, Slavic, Hispanic/Latina/Latino, Japanese, communities of faith, and public sector communities. The Grants Review Committee (GRC) was appointed by the full EPAP and membership of the GRC included representation from the business, African, African American, Hispanic/Latina, school, and public sector communities.

The proposed application, criteria, and funding allocation were approved at the April 2012 general meeting of the East Portland Action Plan. 64 people were in attendance, representing business, neighborhood association, Chinese, Japanese, Hispanic/Latino/Latina/ Mexican American, faith, environmental justice, environmental activist, Native American/Indian, African American, African, Neighborhood Association, Lao, Lesbian/Gay/Bi-sexual/Transsexual, Questioning/Queer, school, social service, environmental justice, disabled, Somali, youth, elder, urban renewal, government, housing, Vietnamese, social change, Brazilian, Philippine, health, bike, and arts communities.

The application was:

1. Posted on the East Portland Neighborhood Office/ East Portland Action Plan website;
2. Hard copy distributed at the April East Portland Action Plan general meeting, the EPAP Civic Engagement Subcommittee meeting, out of the East Portland Neighborhood Office and Rosewood Initiative offices, East Portland Parks Coalition meeting, East Portland Land Use and Transportation meeting, EPAP Housing Subcommittee, and through community partners.

3. Emailed to the EPAP, EPNO, EPN, ONI, and Jeri Williams list serves, with requests to forward, as well as sent to the ONI media list.

Two grant support sessions were held: one morning and one evening session. Both sessions offered language interpretation, childcare, and were in mobility accessible locations. The grant application made it known that the Grant manager was available to assist, review, and provide input as the grant application was being developed. The grant application made it known that applications could be submitted in any language and submitted hand written, electronically, and/or hardcopy.

The EPAP Grants Review Committee (GRC) read and scored the applications in accordance with the approved criteria and met for comparison, negotiation, and final decisions on May 22, 2012. The GRC will report their recommendations at the June, 2012 general EPAP meeting.

Public involvement developed, directed, and decided this Council item.

Members of the East Portland Action Plan Civic Engagement Subcommittee and Grants Review Committee, participants at general EPAP monthly meetings, and the EPAP Advocate designed and implemented the public involvement related to this grant.

7. BACKGROUND ANALYSIS

The Council on February 18, 2009 resolved through acceptance of Resolution No. 36682 to adopt the East Portland Action Plan to inform City Council and City bureaus in the course of decision-making related to long-term planning and capital improvement projects in the East Portland area.

The East Portland Action Plan (EPAP) was developed by the community for the community. Over an eight month process with the City of Portland Bureau of Planning and Sustainability, 268 action items were identified. The result is an Action Plan which contains **Strategies** and **Actions** that provide guidance and direction to public agencies, non-profit organizations, businesses and individuals to address the opportunities and challenges facing East Portland.

The fiscal year 2011-12 City budget allocated \$279,692 to be used for EPAP implementation.

Included in this budget allocation was \$150,000 from the FY 2011-12 EPAP budget to be applied toward EPAP priority projects established at general EPAP meetings during FY 2011 - 12. These funds are stipulated to allow community members, neighborhoods, business associations, non-profits and other groups to seek funding to address the Action Plan items.

The EPAP 2012 – 2013 Grants Program competitive grant allocation process cycle received 12 grant applications for a total request of \$118,279.95. We had \$60,000.00 to allocate for this program. The Grant Review Committee selected 6 proposals for awards totaling \$54,805.00. The duly designated EPAP Grants Review Committee, in accordance with the proposal instructions, utilized the EPAP

Prioritization Criteria established by the EPAP Civic Engagement Subcommittee (with special consideration given to the following criteria: Experience with cultural specific underserved populations with language appropriate communication; Experience leading entry level civic engagement training; Experience doing community involvement with cultural specific populations with language appropriate communication; Community building project leading to more community involvement; number of people to be directly engaged; Ability to link to the existing services in the community tailored to the needs of cultural and language specific populations; Promotion of health and well-being of families, children, individuals, and communities; Involvement between multiple partners; and Demonstration of matching contributions of \$ or time).

The East Portland Action Plan and Office of Neighborhood Involvement have evaluated the proposals and grant paperwork and determined that the grantees are qualified to provide the services to be provided under the grant agreements.

Therefore, ONI is requesting authorization to enter grant agreements and release grant funds to the selected applicants.

The ordinance to authorize this agreement is filed Thursday June 14, 2012 as an emergency ordinance to allow immediate execution of the agreements and prevent delay in project activities

8. FINANCIAL IMPACT

ONI's budget for FY2011-12 included funds for the East Portland Action Plan, and those funds have been only partially spent. \$54,805 of the funds is allocated for the East Portland Action Plan Civic Engagement Grants Program. The grant agreements do not exceed the funds available. No new revenue will be generated.

9. RECOMMENDATION/ACTION REQUESTED

Approve the ordinance and allow the ONI Director to proceed with the grant agreements between the City of Portland and: Buddhatham-Aram, Inc. on behalf of the Laotian Cultural Center; Faith Baptist Church of Portland Oregon on behalf of the Russian Speaking Network; Native American Youth & Family Center (NAYA); East Portland Neighbors on behalf of the Latino Learning Community/Comunidad Latina Aprendiendo; Vietnamese Community of Oregon; and City Bible Church on behalf of the Zomi/Zo/Chin Community.
