The City of Portland has been awarded an FY 2011 Urban Areas Security Initiative (UASI) Grant #11-170. The City of Portland is the official administrator for the UASI regional grants. The Clackamas County is a stakeholder in the UASI region. The FY 2011 UASI Grant award of \$4,925,160 (Ordinance #185227) is for addressing the unique equipment, training, planning, exercise and operational needs of large urban areas.
