City Council Members:

The city of Portland has an ordinance for jaywalking; it calls for a fine of \$94.00. I have never seen a ticket issued for this violation of this ordinance, The following are some examples I personally observed.

On Monday, June 11, I saw a middle aged woman cross the street at 117th & Stark, with an ambulance with blaring sirens This happened at 8:00 .m., the ambulance had to stop, because the woman would not yield.

At Cesar Chavez Blvd, I observed a young man not in the crosswalk run in front of 4 lanes of traffic. This happened at 2:30 p.m. on Thursday, June 14th, 2012.

On June 19th, I observed 14 persons including 2 Multnomah sheriffs, cross against the walk sign at 5th and Jefferson This would have generated \$1316 This happened at 11:00 in one hour. If you take that over an 8 hour period, you would generate \$10,258. The 30 day rate would be \$31,584.

Enforcement of this ordinance would add to the city's coffers and increase the safety for your citizens and tourists.
