*Authorize a contract to purchase one work assist lift vehicle for \$15,970 funded by Revenue bond, archives space acquisition project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The CityFleet Division of the Bureau of Internal Business Services recognizes the need for one work assist lift vehicle to be used by the Auditor's office to facilitate retrieving boxes of records from high shelving in the new archives center.
- 2. It has been determined that one (1) work assist lift vehicle needs to be purchased for the Auditor's office work assist lift vehicle #N12020, Exhibit A attached.
- 3. The estimated cost of this work assist lift vehicle is \$15,970.00.
- 4. The City now desires to purchase this vehicle.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to issue a purchase order for one work assist lift vehicle, Exhibit A, in accordance with City Code 5.33.
- b. The Mayor and City Auditor are hereby authorized to pay for said purchase from the Revenue bond, archives space acquisition project.

Section 2. The Council declares that an emergency exists because delay in proceeding with the purchases would result in additional expense and unnecessarily deprive the City of the use of this vehicle at an early date; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
