

ORDINANCE No. 185489

*Authorize a competitive solicitation for construction management, inspection and project support personnel (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services has a need for supplemental construction management, inspection and project support personnel on an as-needed basis during peak construction periods for the projects included in the bureau's Capital Improvement Program.
2. The estimated cost is \$12,000,000 over a three year period. Funds are available in the Sewer System Operating Fund, FY 2012-2013 Bureau of Environmental Services, Cost Center ESEN000020.
3. The Bureau of Environmental Services seeks Council authorization for Procurement Services to issue a Request for Proposal (RFP) resulting in up to two not-to-exceed contracts.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to facilitate the use of the competitive solicitation process in order to obtain the most responsible and responsive offer providing not-to-exceed contracts for construction management, inspection and project support personnel.
- b. Upon Council acceptance of the Chief Procurement Officer's Report, Procurement Services is authorized to negotiate and execute contracts, provided the contracts have been approved as to form by the City Attorney's office.

Section 2. The Council declares that an emergency exists because the Bureau requires continued access to construction management, inspection and project support personnel for projects currently under construction. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
