I will also ask that the Office of the Portland Ombudsman proceed with the Complaint filed on 2012 Jun 12 Tuesday 21:40 U (9:40 PM PT) in regards to the formation of the Citizen Advisory Committee for the Ten Year Facilities Plan that has been started in secret for the Tryon Creek Wastewater Treatment Plant.

Further the previously filed Complaint be expedited prior to the next meeting of the Oversight Committee. This I hope will stop a defective process that has been designed to discriminate against residents of the Birdshill CPO / NA. A process of facility upgrade review by citizens for which not one resident from the Birdshill area has ever been invited to participate in the previous forty five (45) years of the plant's existence and operation on our community's southern boarder since circa 1967.
