

RESOLUTION No. 36946

Review the City franchise system for collecting solid waste, recycling and composting.
(Resolution)

WHEREAS, on March 12, 2008, Council passed Ordinance No. 181666 granting ten-year residential solid waste, recycling and composting collection franchises; and

WHEREAS, that franchise ordinance provides periodic review to assess the franchise system; and

WHEREAS, the review will assess the effectiveness of the franchise system in meeting goals for waste reduction and recycling, customer service and cost effectiveness for ratepayers; and

WHEREAS, guiding principles, included as Attachment A, provide direction to the franchise review process and identify the issues to be examined.

NOW, THEREFORE BE IT RESOLVED that the Bureau of Planning and Sustainability conduct a review of the solid waste, recycling and composting collection franchise system as outlined in Attachment A of this resolution and report the findings within 180 days of passage of this resolution.



