

ORDINANCE No. 185515

*Extend contract with CMTS Inc. to add contractual spending authority for qualified temporary Inspection and Engineering Technician personnel (Ordinance; amend Contract No. 30001969)

The City of Portland ordains:

Section 1. The Council finds:

1. Bureau of Transportation entered into a 3-year flexible services contract with contractor CMTS Inc. to provide qualified temporary Inspection and Engineering Technician personnel during peak seasonal workload demands.
2. The original contract with a not-to-exceed amount of \$500,000 expired on May 15th, 2012. An amendment to increase the spending authority by \$125,000 was approved in May 2010.
3. A contractual spending increase of \$1,000,000 was approved by Council in June 2010 to assist PBOT in meeting the increased workload demands from ARRA projects.
4. A Contract extension was approved by Council in November 2011 to allow the city time to prepare a new formal solicitation.
5. The formal solicitation has advertised and is being let in compliance with the new state law requiring a Qualification-Based-Selection process.
6. Extensive coordination has been accomplished between the Bureau, Procurement Services, and the Oregon Department of Transportation to develop contract language so that the services can be utilized on federal-aid projects.
7. A contractual spending increase is needed for the current contract with a not-to-exceed amount of \$250,000 and a revised contract termination date of October 30th, 2012, to allow time for the new contract to be executed.
8. Services will be paid for by various externally funded projects.

NOW, THEREFORE, the Council directs:

- a. That the Chief Procurement Officer is authorized to execute the proposed amendment, which has been approved by the City Attorney as to form, substantially in accordance with the amendment attached to the original of this ordinance and, by reference, made a part hereof.

Section 2. The Council declares an emergency exists because employees are currently working under the existing contract and need to continue without delay; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
