

ORDINANCE No. 185518

- * Accept donation of two Hi-Lift First Responder Jacks and support supplies from the Shirlee Ann Foundation. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Shirlee Ann Foundation donated two (2) FR-485 48 inch Hi-Lift First Responder Jacks and two (2) HK-R handle keepers, to Portland Fire & Rescue (PF&R) to be used for technical rescue and other fire and life safety incidents in the City of Portland.
2. The approximate value of the donation is \$481.34.
3. The Fire Chief recommends that the Council accept the donation from the Shirlee Ann Foundation.

NOW, THEREFORE, the Council directs:

- a. The City Council accepts the donation of the two (2) Hi-Lift First Responder Jacks and support supplies for Portland Fire & Rescue, and thanks the Shirlee Ann Foundation for its donation.

Section 2. The Council declares that an emergency exists because it is important that these items be put to use as soon as possible; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
