## RESOLUTION No. 36949

Authorize the submittal of a boundary change request to the State of Oregon to move 4.2 acres from the East Portland Enterprise Zone to the Portland Enterprise Zone (Resolution)

WHEREAS, the Oregon Enterprise Zone Act, ORS 285C.045-250, authorizes the designation of Enterprise Zones in urban areas and provides that property tax abatements, job creation, and local municipal incentives are desirable to stimulate economic development in economically depressed areas;

WHEREAS, on June 14, 2012, the Portland City Council ("Council") authorized the Portland Development Commission ("PDC") to submit an application to the State of Oregon for designation of the East Portland Enterprise Zone (E-Zone) with an Electronic Commerce (E-Commerce) overlay;

WHEREAS, on July 1, 2012, the Director of Business Oregon designated the East Portland E-Zone, however the E-Commerce designation was not approved due to lack of available designations;

WHEREAS, Cascade Energy is committed to making a significant investment in the Convention Plaza building at the Burnside Bridgehead site located in the East Portland E-Zone, yet they need to access tax credits associated with the E-Commerce program;

WHEREAS, the existing Portland E-Zone designated by Business Oregon on July 1, 2008 already has an E-Commerce overlay and can be expanded up to a total size of 12 square miles, in accordance with ORS 285C.115; and

WHEREAS, the Port of Portland has previously consented to the creation of the Portland E-Zone and East Portland E-Zone and will hold a public hearing on August 8, 2012 addressing the boundary request.

NOW, THEREFORE, BE IT RESOLVED, that the Council requests, as sponsor of the East Portland E-Zone and Portland E-Zone, that the Convention Plaza building and associated tax lots at the Burnside Bridgehead site be moved from the East Portland E-Zone into the Portland E-Zone as shown in the maps attached hereto as Exhibit A;

BE IT FURTHER RESOLVED, that the Council authorizes the PDC, as zone manager, to submit a request on behalf of the City to the State of Oregon for minor boundary changes to the East Portland E-Zone and Portland E-Zone; and

BE IT FURTHER RESOLVED, that the City has complied with ORS 285C.115 and OAR 123-650-7000.
