

ORDINANCE No. 185549

* Amend contract with Environmental Hazard SVC'S LLC for an additional \$18,000 and extend contract through June 30, 2013 to provide additional lead sample analysis (Ordinance; amend Contract No. 30002316)

The City of Portland ordains:

Section 1. The Council finds:

1. On July 1, 2011 a contract was entered into between the City of Portland (City) and Environmental Services LLC to provide lead paint sample laboratory analysis services.
2. The original contract amount was \$18,000 with an expiration date of June 30, 2012.
3. Additional lead paint sample analysis services are required. The Portland Housing Bureau (PHB) recommends that Contract No. 30002316 with Environmental Services LLC be amended to increase the compensation by \$18,000 and extend the expiration date to June 30, 2013.
4. The additional compensation under this Ordinance comes to \$18,000, which is 100% of the original compensation amount of \$18,000. The new not-to-exceed amount of the contract is \$36,000.
5. Sufficient funding resides in the FY12-13 PHB budget.

NOW THEREFORE, the Council Directs:

- a. The Chief Procurement Officer is authorized to amend Contract No. 30002316 with Environmental Services LLC for services in accordance with Amendment No. 1 attached hereto as Exhibit A.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Environmental Services LLC chargeable to the Portland Housing Bureau when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because of the need for uninterrupted services for the analysis of lead hazards. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
