ORDINANCE No.

* Accept and appropriate a grant in the amount of \$200,000 from the State of Oregon for operation of an integration program for senior citizens who have developmental disabilities (Ordinance).

The City of Portland ordains:

Section 1. The Council finds

- 1. Portland Parks & Recreation's (PP&R) Senior Recreation program provides recreation integration to developmentally disabled senior adults.
- 2. The State of Oregon, Department of Human Services desires to contract with Portland Parks & Recreation's Senior Recreation program to provide these services, which PP&R has successfully done since FY 1983-84.
- 3. The State of Oregon has notified the City of Portland that it will award a grant for the operation of an integration program for senior citizens who have developmental disabilities, to Portland Parks & Recreation in the amount of \$200,000.
- 4. No match is required by this grant.
- 5. This grant will only fund the Senior Center project.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the State of Oregon for the for operation of an integration program for senior citizens who have developmental disabilities in the amount of \$200,000 and to execute an agreement in substantially the form of the attached exhibit for this purpose.
- b. The FY 2012/2013 budget is hereby amended as follows:

<u>GRANTS FUND</u> Fund 217 Business Area – PK Bureau Program Expenses – \$200,000

<u>Provider Fund</u> Fund 706 Business Area – MF Bureau Program Expenses– \$2,532

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Director of Portland Parks & Recreation of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by the State of Oregon for the grant, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the City of Portland Council.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.


