ORDINANCE No. 185575

*Accept a private grant from The Trust for Public Land to benefit the River View Natural Area. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. In July of 2011, the City of Portland (City), through its Bureau of Parks & Recreation (Parks) and Bureau of Environmental Services (BES) purchased the 146 acre River View Natural Area from The Trust for Public Land (TPL).
- 2. This acquisition linked Forest Park with Tryon State Park, and connected trails, and protected wildlife habitat and streams that feed the Willamette River.
- 3. TPL wishes to give the City a private grant of \$250,000 that can be used for any of the following purposes: a. to restore, maintain, and operate the River View Natural Area; b. to reduce the acquisition costs; c. to benefit the River View Natural Area in some other way.
- 4. A portion of the purchase price was paid for with a loan from The Trust for Public Land. Parks and BES agree that the grant should be used to pay off the remaining balance of the loan.

NOW, THEREFORE, The Council Directs:

- a. The Director of Parks and Recreation is authorized to accept a private grant of \$250,000 from The Trust for Public Land to be used for the benefit of River View Natural Area.
- b. The grant will be accepted on terms and conditions substantially similar to those stated in the agreement attached hereto, which the Director of Parks and Recreation is authorized to execute.
- c. The grant funds shall be used to pay off the loan from TPL to the City.
- d. The FY 2012/13 budget is hereby amended as follows:

Parks CIP Fund

Fund 40200

Business Area PK

Bureau Program Expense - \$250,000

Section 2. The Council declares that an emergency exists in order to avoid further delay in receipt of a grant needed to pay off already incurred acquisition costs; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
