ORDINANCE No. 185588

*Authorize application to the Oregon Military Department, Office of Emergency Management for a grant in the amount of \$48,707 for the sustainment of a Community Emergency Notification System. (Ordinance)

The City of Portland ordains:

Section 1. The Council Finds:

- 1. The State Homeland Security Grant Program (SHSGP) supports the implementation of state and local homeland security strategies to address the identified planning, organization, equipment, training, and exercise needs to prepare for, respond to and recover from and natural or man-made disaster.
- 2. The Portland Bureau of Emergency Management (PBEM) will apply to the Oregon Military Department, Office of Emergency Management for an SHSGP FY 2012 grant in the amount of \$48,707.
- 3. This money would be used to continue funding of a Community Emergency Notification System.
- 4. City Code requires that grant applications be approved by ordinance prior to submission. Due to the short timeline for submission of the application, an ordinance was not filed. PBEM is submitting to Council for approval of the application by ordinance.
- 5. No match is required by this grant.

NOW THEREFORE, the Council Directs:

- a. The Mayor and Portland Bureau of Emergency Management are authorized to application to the Oregon Military Department, Office of Emergency Management for a grant in the amount of \$48,707.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
