

**ORDINANCE No. 185592**

Authorize a contract and provide payment for construction of the South Airport Basin Phase 4 Pump Stations and NE 47<sup>th</sup> Ave Frontage Improvements Project No. E06790 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has a need to construct two, new sewage pumping stations to serve unsewered areas in the South Airport Basin area of North Portland.
2. The construction of the pump stations has been identified as a priority project within the BES System Development Program.
3. The estimated construction contract cost is \$3,320,000. The level of confidence in the cost estimate is optimal. Funds are available in the Sewer System Operating Fund, FY 2012/2013 Budget, Bureau of Environmental Services, WBS E06790.C14.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
