

ORDINANCE No. 185593

Authorize a contract and provide for payment for the construction of the NE Klickitat Neighborhood Greenway Project No. E10126 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. 26 green street facilities need to be installed to improve stormwater management, pedestrian safety, and bicycle movement. Approximately 750 feet of new combined sewer pipe on NE Klickitat needs to be constructed to provide standard sewer service to existing properties.
2. Environmental Services has prepared plans and specifications for new green street facilities and new sewer pipe including manholes, service laterals, stormwater inlets and inlet pipes.
3. Environmental Services requires the furnishing of labor and materials to construct this project.
4. The estimated cost is \$980,000. The level of confidence in this estimate is "High". Funds are available in the Sewer System Operating Fund, FY 2012-2013 Budget, Bureau of Environmental Services, WBS E10126.C60.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
