ORDINANCE No. 185607

Authorize a contract and provide for payment for the construction of the Overlook Sewer Replacement Project No. E10261 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Approximately 17,000 feet of combined sewer pipe in north Portland from N Fremont St to N Ainsworth St between Interstate 5 and the Mocks Crest Bluff are in a seriously deteriorated condition and need to be repaired or replaced.
- 2. Environmental Services has prepared plans and specifications for rehabilitating the deteriorated sewer pipe including manholes, service laterals, stormwater inlets and inlet pipes.
- 3. Environmental Services requires the furnishing of labor and materials to construct this project.
- 4. The estimated cost is \$7,900,000 with an optimal level of confidence. Funds are available in the Sewer System Operating Fund, FY 2012-2013 and FY 2013-2014 Budgets, Bureau of Environmental Services, WBS Element E10261.C60.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
