# a) What impacts are anticipated in the community from this proposed Council item?

This project will cause noise, dust, vibration, traffic congestion, temporary parking loss, access issues, detours, lane reductions and street closures in the construction zone, and disruption to normal neighborhood activity.

The Overlook Sewer Replacement Project is part of a series of projects over the next 3 to 5 years that will repair sewer pipes rated by the Bureau of Environmental Service's Asset Management rating system as highly likely to fail due to the fact that they are approximately 80 - 100 years old. Repairing these deteriorating sewer pipes will increase the sewer collection system capacity and reliability for this area of Portland.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

Information about the project and impacts to the public has been provided to residents and property owners within and near the project area since August 1, 2011.

Overlook Neighborhood Association: Ongoing notification and involvement by flyer, email, and in person since January, 2012.

Overlook Business Association: I met with the members on February 21<sup>st</sup> and presented an overview of the project. Ongoing notification and involvement will continue during the project.

A workshop for property owners with non-conforming sewers was held on April 4, 2012.

The project team met with representatives from Adidas on June 14<sup>th</sup> to discuss impacts to their business.

The Portland Bureau of Transportation (PBOT) was involved during the design phase in regard to traffic control plans for N Greeley Avenue, N Greeley Avenue at Sumner Street (the main entrance to the Adidas campus), N Killingsworth Street, N Going Street, N Ainsworth Street, and N Interstate Avenue. Particular attention was paid to the needs of businesses and residents and transportation infrastructure users for access and convenience.

# c) How did public involvement shape the outcome of this Council item?

Bid documents incorporated knowledge gained from design phase outreach. This included specific construction schedule restrictions for work near schools in the project area, requirements for notification

of busnesses and residents prior to construction activities, and requirements for local access during construction.

#### I. RECOMMENDATION

Authorize a contract and provide for payment for the construction of the Overlook Sewer Replacement Project, BES Project No. E10184 (Ordinance)

#### II. **BACKGROUND**

The purpose of this contract will be to construct approximately 17,000 feet of 8-inch to 18-inch combined sewer pipe in north Portland. The existing sewers are seriously deteriorated and their failure will compromise the health and safety of the residents. There are twenty-nine party sewer properties within the project site which will receive separate service laterals as part of this project.

This project is one of the BES Maintenance and Reliability "Structural Rehabilitation of Combined and Sanitary Sewers" projects. The construction methods will be open-cut excavation, microtunneling, and bore and jacking. In addition to replacing the sewer mains, this project will also replace manholes, service laterals, stormwater inlets and inlet pipe.

This project allows BES to continue to operate and maintain the public sewer system. Repair and rehabilitation of sewer pipes is consistent with the Bureau of Environmental Services Mission and City's Sewer Policies:

Provide sewage and stormwater collection services to accommodate Portland's current and future needs and;

Protect and promote healthy ecosystems in our watersheds.
