## 7. BACKGROUND/ANALYSIS

This Ordinance settles a property damage claim by Pacific Power involving the Portland Bureau of Transportation. The settlement amount is \$28,000. The claim arises from a failure by PBOT's Locate Group to mark the location of a sewer lateral, after Pacific Power had called for utility locates for its planned power pole replacement on NE 62<sup>nd</sup> Ave. PBOT did not mark the underground location of the sewer lateral because Pacific Power was replacing the pole in the same location, and the City's responder therefore assumed there would be no conflict with the sewer lateral. The new pole, however, was set deeper, crushing the sewer lateral serving the adjacent home. PBOT's Locate Group has since changed its procedures, and is marking all sewer laterals in response to locate tickets for pole replacements.

The \$28,000 settlement amount is a negotiated settlement with Pacific Power. It includes reimbursing Pacific Power for the costs it paid for the homeowner's sewage clean-up, for replacement of the sewer lateral, and for Pacific Power's additional expenses for its own work at the site.

## 8. FINANCIAL IMPACT

Approval of the settlement would result in a payment of \$28,000 from the liability fund.

## 9. RECOMMENDATION/ACTION REQUESTED

Approve settlement of Pacific Power property damage Claim in the sum of \$28,000.
