Clarify intended policy, address unintended consequences, and fix technical errors identified with the newly adopted tree regulations that are scheduled to become effective July 1, 2013. Amendments will enable a smooth transition to and ongoing implementation of the new tree regulations.

The new Title 11, Trees and amendments to Title 33 and other titles were adopted on April 11, 2011. Title 11 and the bulk of the Title 33 amendments are scheduled to go into effect July 1, 2013. The proposed amendments clarify and correct the new and amended code provisions and will not have an effect on the cost of the originally adopted legislation.

**a) What impacts are anticipated in the community from this proposed Council item?** The housekeeping amendments are intended to simplify code administration and clarify intent, making the codes more useable for staff and community members.

**b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?** Public involvement for the amendments took place between February 2012 and May 2012. Staff attended meetings held by the Citywide Land Use Group and Development Review Advisory Committee in February 2012. In April 2012 staff updated the Urban Forestry Commission on the upcoming amendments. Public hearing notices were mailed in April 2012 to approximately 800 individuals and organizations on the Bureau of Planning and Sustainability's legislative mailing list. An email update including tree code implementation activities and public hearing dates was sent in May 2012 to approximately 400 individuals and organizations that comprised the Citywide Tree Project mailing list. The Urban Forestry Commission and Planning and Sustainability Commissions each held a public hearing in May 2012.

**c) How did public involvement shape the outcome of this Council item?** Communication with members of the public both prior to and during the two commissions' hearings helped staff to hone aspects of the code language and ensure that policy intent was clear. The commissions also provided feedback that resulting code clarifications and advice will inform upcoming public outreach activities before the codes become effective. Some issues raised during this process were outside the scope of this amendment package and were not addressed within the context of this item.



No. The recommended housekeeping amendments are limited in scope and do not change the intent of the new tree regulations. Additional and future public involvement will address key components of the adopted Citywide Tree Project, in anticipation of the new rules becoming effective in July 1, 2013. An outreach and communication strategy is being developed as part of the Bureau of Development Services and Parks and Recreation ongoing commitment to public involvement and education.
