

ORDINANCE No. 185663

* Amend contract with David M. Corey, Ph.D., P.C. to provide additional funds for psychological examinations for the Portland Police Bureau (Ordinance; amend Contract No. 35139)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau finds value in having officer applicants submit to a psychological examination and to require psychological fitness for duty examinations as needed.
2. David M. Corey, Ph.D., P.C. has provided these services to the bureau through a series of contracts awarded by competitive bidding processes since 2001.
3. Contract No. C35139 with David Corey, Ph.D., P.C. was executed in January 2004 for a term of two years expiring December 31, 2005 if not extended for additional time. The compensation to the contractor was limited to \$100,000 during the two year term of the contract.
4. Amendment No. 1 to the contract was passed to extend to term of the agreement for an additional year and increase the compensation by an amount of \$86,775.
5. Amendment No. 2 to the contract was passed to extend the term for an additional year and increase the compensation by an amount of \$86,775.
6. Amendment No. 3 to the contract was passed to extend the term of the agreement for an additional year with no additional compensation.
7. Amendment No. 4 to the contract was passed to extend the term for an additional two years and increase the compensation by \$195,000.
8. Amendment No. 5 to the contract was passed to extend the term for an additional year with no additional compensation.
9. Amendment No. 6 to the contract was passed to extend the term of the agreement for an additional three months with no additional compensation.
10. Amendment No. 7 to the contract was passed to extend the term of the agreement through August 31, 2012 based on City Council directive to allow time to verify the procurement process used to establish a new contract for these services. Prices for services were amended to reflect COLA-adjusted rates from the initial date of contract.
11. Amendment No. 8 to the contract was passed to extend the term of the agreement to October 31, 2012.

12. Amendment No. 9 will add an additional \$20,000 in compensation to pay for services rendered through the term of this contract.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is hereby authorized to execute amendment No. 9 to Contract No. C35139 between the City of Portland and David Corey, Ph.D..

Section 2. The Council declares an emergency exists because delay in proceeding with this amendment will unnecessarily delay the payment due for services provided under the existing contract. Therefore, this ordinance shall be in full force and effect from and after its passage by City Council.


