- **Purpose of Agenda Item:** This report provides a one-year update on Portland's single use plastic checkout bag policy.
- 6. History of Agenda Item/Background: Ordinance No. 184759, adopted July 21, 2011, amended City Code to promote reusable checkout bags and reduce use of single-use plastic checkout bags. The ordinance, implemented October 15, 2011, required defined stores only provide recycled paper bags or reusable bags as checkout bags to customers. The ordinance includes grocery stores with gross annual sales of \$2 million and large retailers over 10,000 square feet that have a pharmacy. The ordinance directs the Bureau of Planning and Sustainability (BPS) to return to Council with a report within one year of the effective date.
- 8. What individuals or groups are or would be supportive or opposed to this action?

 No groups are expected to be opposed to a report on this policy. Various stakeholders would be supportive of a report on this policy including effected retailers and environmental and conservation organizations.



9. How does this relate to current City policies? This report is required by Ordinance No. 184759. Ordinance No. 184759 is supported by Resolution No. 35338, Sustainable City Principles; Resolution No. 36384, the adoption of the Watershed Management Plan; Resolution No. 36423, the adoption of goals for the City's solid waste and recycling system.
