The Oregon Department of Transportation will reimburse the City a maximum of \$70,000 for expenses incurred for sworn personnel overtime worked on the 2013 Multnomah County DUII Intensive Supervision Program (DISP).

Bureau personnel assigned to the Traffic Division remain under the supervision of the Portland Police Bureau.
