The proposed legislation will authorize the Portland Housing Bureau to provide matching resources for the three-year, \$1,000,000 HUD Healthy Homes grant awarded to the Multnomah County Health Department that will provide funding to assess and correct housing-related environmental health and safety hazards that may contribute to illness, injury, or adverse health outcomes for vulnerable populations such as children or elderly.
