

ORDINANCE No. 185676

Amend an Intergovernmental Agreement with Portland Community College for ongoing Emergency Medical Services training (Ordinance; amend Contract No. 30001806)

The City of Portland ordains:

Section 1. The Council finds:

1. On December 15, 2010, Council passed Ordinance 184313, authorizing Contract No. 30001806 with Portland Community College for on-going training to meet the State of Oregon and Multnomah County Continuing Medical Education courses required for firefighters to maintain their EMT certifications.
2. Section 4.c.of that IGA states that employees may make up missed classes by attending regularly scheduled classes on campus at the contract rate, but doesn't define that rate.
3. Amendment No. 1 of Contract 30001806 changes the name of the school and school phone numbers, defines the individual class rate, and raises the cost of individual cards for students.
4. There is a potential for PF&R to incur an additional \$5,000 every four (4) years for individual classes.
5. PF&R has the funds for this training in its budget.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Safety and Auditor are authorized to execute an amendment to Contract 30001806 with Portland Community College CLIMB Center for Advancement-Health Professionals as outlined in a form substantially in accordance with the amendment attached hereto as Exhibit A, at a cost not to exceed an additional \$5,000 every four (4) years.
